

TERMS AND CONDITIONS OF THE WEBSITE www.automationstechnik.pl

I. General Provisions

The owner of the website www.automationstechnik.pl is Automationstechnik, with its registered office at ul. Rzemieślnicza 20 B, 30-363 Kraków, NIP: 679-11-68-790, REGON: 003915177, hereinafter referred to as the "Company."
